Facility: The pool at the YWCA of Gettysburg and Adams County is a 6 lane, 25-meter pool. An

Omega timing system, with touch pads at the finish end for 50 meter and longer events, will be used. The meet will be run using Hy-tek Meet Management software. An electronic starter and single line display board will be utilized. **Teams will be assigned areas in the gymnasium and swimmers will be seeded from there**. Swimmers are to remain off the pool deck unless they are participating in or being staged for an event. Bleachers are available in the pool area for spectators. No food or beverages will be

allowed in the pool area.

Entries: All entries must be received by Friday, July 13^h at 9:00 PM. E-mail entries to Megan

Maslowski at mmaslowski@ywcagettysburg.org. All swimmers must be active on their team's roster. Eligibility is determined by participation in two (2) division "A" dual meets. Entries must be in short course meters. Please complete all entries with Hy-Tek

software. The team manager import file can be found on the CASL web site.

Each swimmer may be listed in three (3) events. Swimmer must swim in their age as of 6/1/07, with the exception of relays, in which they may move up no more than two (2)

age groups.

Admission: Admission is \$2 for all non-swimmers. Programs will be available for \$3. Highlighters will be available for \$1. Swimmers and volunteers admitted free. Coach's packets will

be at the admissions table, with meet information and volunteer badges included.

Directions to the YWCA of Gettysburg and Adams County

From The North: Route 15 South. Exit at York Street. Turn right at the end of the ramp.

**Follow York Street (route 30) into the Gettysburg Square. Continue straight through the square. Turn left at the first light, Washington Street.

Turn right at the first light, West Middle Street. Go through two traffic lights. At the bottom of the hill, you will see the entrance to the YWCA on

the right.

From the East: Route 30 West. After passing over Route 15, follow from ** above.

From the South: Route 15 North. Exit at York Street. At the end of the ramp, turn left.

Follow from ** above.

From the West: Route 30 East. After you pass the first light in Gettysburg (at Battlefield)

Turn Right onto Confederate Avenue (Across from General Lee's Headquarters). At the light turn Right onto West Middle Street. The

YWCA will be at the bottom of the hill on the right hand side.
