Facility: The Cumberland Valley High School Natatorium is an eight (8) lane 40 meter pool divided by a bulkhead at 25 yards, with a six (6) lane warm-up/warm-down area opposite the competition pool. A fully automatic Colorado 5 timing system with display board, touch pads at the finish for 9 & over swimmers and "2-button finish" for 8&U swimmers will be used. We will be using Hy-Tek meet management software. Team areas and meet seeding will be provided for swimmers. Spectator seating is available in the gallery area above the pool.

Entries: This meet is open to all Division 4A CASL swimmers that are registered with their teams and swam a minimum of three league meets in the course of the season. Each swimmer may swim a maximum of three (3) individual or relay events. The swimmers age will be determined as of June 1, 2011. All entries should be submitted on disk using Hy-Tek meet management software. All entry times should be in meters. If no times are available, enter with a NT in the space provided. Entries must be e-mailed to [cvacmeetdirector@gmail.com](mailto:cvacmeetdirector@gmail.com); however, hard copy must follow within three (3) days. **Deadline for entries is Sunday, July 17, 2011 at 3:00 pm.**

Admission: Admission to the meet will be \$3.00. Divisional volunteers are admitted free with proper credentials.

Concessions: Various food items will be available throughout the day in the lobby outside the Natatorium.

Meet Rules: The meet will be governed by National Federation Rules, as amended by the Capital Area Swim League.

The following rules are modifications or points of emphasis:

1. False-Start Rule: 8 & under - One false start; all other age groups - No false starts
2. Dual confirmation will be in effect for all starts and relay take-offs.

3. An air horn will supplement the electronic beeper to denote unfair starts.\*

\*When one or more swimmers have obtained an unfair advantage at the start, the race shall continue without recall. If the recall signal is activated inadvertently the race "is recalled" and the Referee/Starter may disqualify the swimmer(s) who left the mark before the start signal. However, the Referee/Starter may also recall the entire heat "without" any false start - if not satisfied with the start. In this case it is called an "unfair start."

4. Swimmers must place feet including toes below the gutter at the start and until feet leave wall. Toes may not be on the gutter prior to, during, or after the start.

5. In-water relay take-offs for 2nd and 4th swimmers in 8 & under relays is defined as follows:

The swimmer shall enter the water when teammate has entered at the opposite end, but no later than when the head of the incoming swimmer passes under the backstroke flags nearest where take-off is to occur. The swimmer shall maintain contact with the end wall with a hand and/or foot by the time the end of the incoming swimmer passes under the backstroke flags nearest the point where take-off is to occur until the incoming swimmer touches the wall.

Safety:

There will be **NO DIVING** from the shallow end (non-block) at any time during warm-ups or during the meet. There will be **NO DIVING** from the starting blocks and no backstroke starts during warm-ups session, with this exception: Limited diving and backstroke starts from the starting blocks in sprint lanes will be permitted, **BUT** only when announced. These rules follow National YMCA Warm- UP Safety Procedures.

## **Cumberland Valley Natatorium - Directions**

**From North** – Take I-81 South to the Route 114 exit and make a left at light - go to traffic light at Rt. 11 - (Giant Store/Sheetz's gas station on right, Silver Springs Commons on left) bear right at light (Rt. 11 south. Proceed approximately 2 miles to the CV Education Park on the right. To get to pool pass the main entrance and stadium and make right onto Dapp Road. Make right onto access road past Stadium and go straight ahead to pool parking. Enter pool at the large "CV" Entrance.

**From South** – Take I-81 North to the New Kingstown exit onto Rt. 11 North. Go approximately 3 miles to school on left - school is located along Rt. 11.

**From the South and PA Turnpike** – Take Route 83 North to Route 581 West to Route 81 South. Proceed to Route 114 (exit 57). Turn left at the end of the ramp onto Route 114 to Route 11 (Carlisle Pike). Turn right onto Carlisle Pike (at the Sheetz) and proceed approximately 2 miles to the CV Educational Park on the right.
